

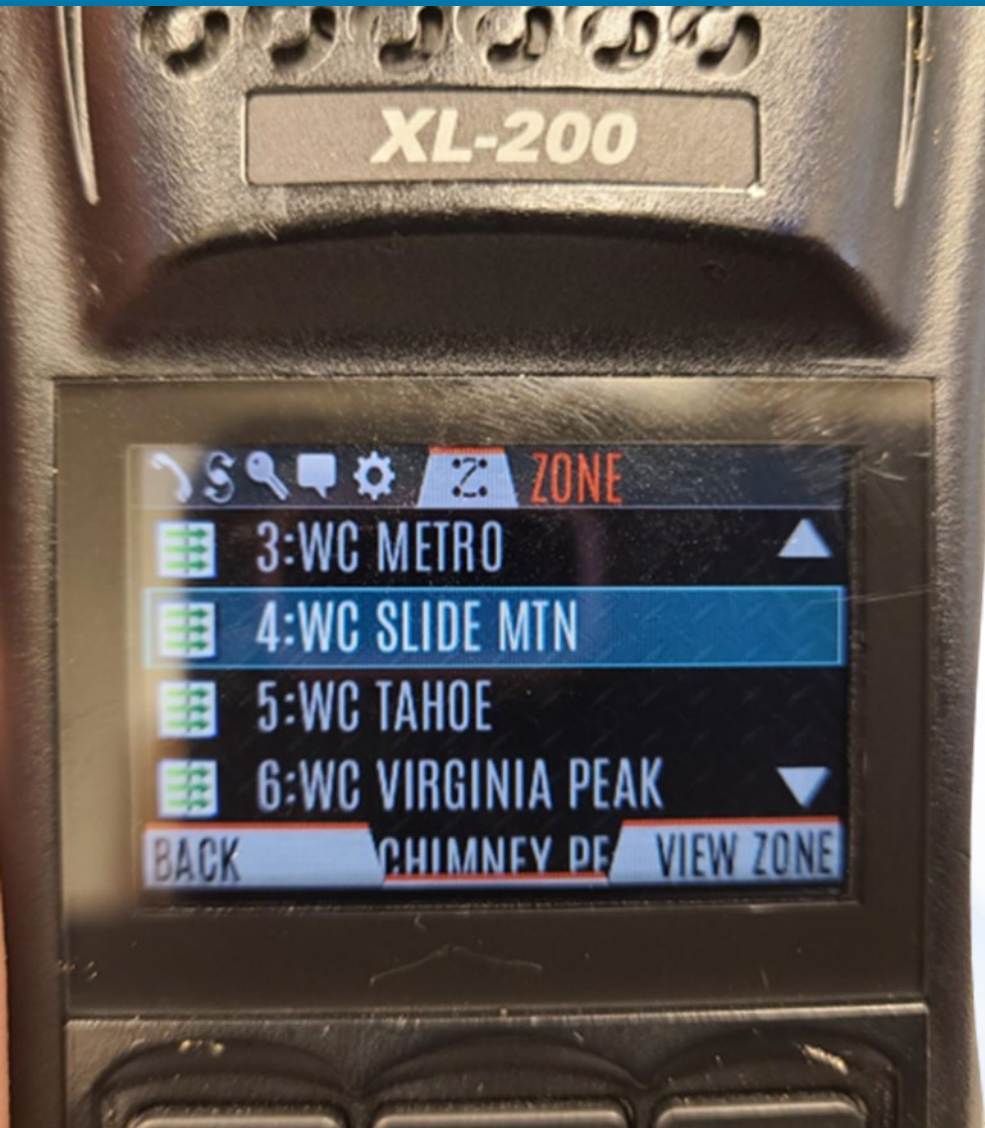

SYSTEM STATUS UPDATE



- **Radio Service Interruptions**

- Some static heard by Pyramid Lake units on EDACS during P25 testing at sites in the area. Caused by overlapping frequencies. Mitigation plan in place for future sites.
- Spectrum dispatch had a series of console disconnections. Route was reengineered. WCRCS continuing to monitor.
- Missing audio noticed on the dispatch consoles. Related to a partner infrastructure upgrade. Regular notifications sent on possible effects. Last day of planned effort- June 18th
- UPS for radio equipment upgraded at the Detention Facility

- **WC Metro P25 Simulcast**

- Generator issue on Red Peak caused the loss of transmitter equipment. Transmitter repaired and generator has been fixed.

Maintenance Recommendations



- Consoles are reaching the age of 7-10 years
 - Dispatch centers should consider creating Maintenance programs within their budgets
 - WCRCS is recommending the purchase of New SDD's drive for the consoles for all dispatch centers:
 - Last 8 tickets with L3Harris TAC results in Hard drive replacements being recommended.
 - SSDs use NAND flash memory to store data. Over time, this memory can wear out, leading to data [corruption](#) and failure.
 - Most modern SSDs use wear-leveling algorithms to distribute writes evenly across the drive, which can help reduce wear's impact. SSD drive only fail at 1.6% versus the 7% failure rate of an HDD.
 - Other Maintenance Items include Dispatch Foot pedals, and Audio Jacks.

System Status Update:



- Backup base stations recommended for Dispatch Consoles (Contact Tyler Gerber-Winn or Tracy Moore)
- Site PMs are underway, RF, Generator, AC, and Tower inspections. Scheduled to be completed before Sept 30 2026
- Radio purchases are under current contracted rates until December 31st, 2026.
