SUBJECT:

PRELIMINARY FISCAL YEAR 2020-2021 WCRCS (WASHOE COUNTY REGIONAL COMMUNICATIONS SYSTEM) BUDGET. A review, discussion and possible action to recommend the fiscal year 2020-2021 WCRCS budget and associated Operations and Maintenance contributions by WCRCS member agencies to the 800 MHz Joint Operating Committee for their approval.

SUMMARY:

The presented FY21 WCRCS budget is based on the fiscal year 2019 – 2020 budget with projected increases in Salaries, Benefits and Overhead. Final numbers for this budget will not be available until January 2020.

The fiscal year 2020-2021 budget agency cost allocation is based on each agency's respective share of the total number of active radios on the WCRCS system during fiscal year 2019.

Before this budget is approved by the Joint Operating Committee, the 800MHz Users committee must first recommend its approval to the JOC.

WCRCS FY20/21 Budget Highlights

Overview of Budget Proposal:

- Total Radio Count increase of 277.
- 1.3% Operations budget increase over FY19 - 20.
- Recommend to maintain 10% contribution to Infrastructure.
- Cost per radio decrease of \$8.34 per radio - per year to \$277.26.

Operations:

- Total Operations Budget: \$1,608,111.59
- Operations Budget increase of \$20,877.10

Infrastructure:

- Recommend to maintain contributions at 10%.
- Operations + Infrastructure budget: \$1,768,922.75
