3. WASHOE COUNTY REGIONAL COMMUNICATIONS SYSTEM FISCAL YEAR 2021/2022 BUDGET (Continued from December 17, 2020 agenda) [For Possible Action] – A presentation of the FY21/22 budget with review, discussion and possible action to recommend that the 800MHz Joint Operating Committee approve, deny or otherwise modify FY21/22 WCRCS budget. Quinn Korbulic – Washoe County Technology Services

Quinn Korbulic, Washoe County Technology Services, shared that at the December meeting, the Committee had asked staff to schedule this special meeting and return with additional Operations budget scenarios for consideration, specifically a flat budget, a 3 percent decrease and a 5 percent decrease. He reviewed the five scenarios as summarized below.

Ed Atwell, UNR, expressed concern with the individual agency contribution amounts considering agencies such as his were looking at budget reductions for FY22; he expressed preference for the scenario with a 3 percent reduction to the Operations Budget.

Chris Ketring, Truckee Meadows Fire Protection District; Keith Mullen, City of Sparks; Jon Kelly, Washoe County School District; expressed preference for Budget Scenario Two after consultation with their agencies. Several agencies noted they had not been directed to consider agency budget cuts for FY22. It was clarified that the proposed options were just for the Operations Budget and the Committee would still have an option to identify their preference for the Infrastructure Contribution amount.

Chair Mullen asked the Committee to provide a recommendation to the Joint Operating Committee based on what the needs are for the system and allow the JOC to consider

any necessary agency finance consideration; the JOC will be presented with all the scenarios. He expressed support for continuing the ten percent contribution to the Infrastructure Fund.

The Infrastructure Fund has an approximate \$900,000 balance which would provide some cushion if the agencies wanted to consider less than the ten percent contribution done previously. Mr. Atwell noted it was to the system's benefit to continue with the ten percent contribution while NDOT is a member.

Ed Atwell, UNR, moved that the 800 MHz Users Committee recommend the Joint Operating Committee adopt the FY22 Budget Scenario with the three percent reductions to the Operations Budget (\$1,560,755); and continue the ten percent contribution to the Infrastructure Fund. The motion died for lack of a second.

Chris Ketring, Truckee Meadows Fire Protection District, moved that the 800 MHz Users Committee recommend FY22 Budget Scenario Two for the Operations Budget (\$1,634,677). Russ Pederson, Washoe County, provided the second. There was no response to the call for further Committee discussion or the call for public comment. Upon the call for a vote, the motion carried with eight in favor, Ed Atwell, UNR, opposed.
