### **SUMMARY**

#### **FOR PRIMARY PSAP (Public Safety Answering Point) CITY OF RENO PUBLIC SAFETY DISPATCH:**

A review, discussion and possible action to approve, deny or otherwise modify a request for funding for Reno Public Safety Dispatch to install eleven (11) monitor mounts – Quick Stack vertical posts directly involved in supporting monitors for West’s MapFlex 9-1-1 program display. This vital mapping component displays locations of calls and incidents on an interactive map that details information about a call including wireless addresses, regional pictometry overlays that, among many tools, are used in the PSAP on a day to day basis. Including freight and Installation services for a cost not to exceed \$ 3,127.41.

#### **NRS APPLICABLE:**

NRS 244A.7645 Provides approval of costs associated with maintenance, upgrade and replacement of equipment necessary for the operation of the enhanced telephone system.

#### **STAKEHOLDER REVIEW(s)**

Stakeholder is a primary Public Safety Answer Point (PSAP) – City of Reno Public Safety Dispatch.

#### **PREVIOUS ACTION & BACKGROUND**

No previous actions were taken for City of Reno Public Safety Dispatch.

#### **FISCAL IMPACT**

The Enhanced 9-1-1 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

**RECOMMENDATION**

It is recommended that the E911 Emergency Response Advisory Committee approve the request for funding the costs associated with Xybix Systems, Inc. for the purchase of eleven (11) Monitor Mount – Quick Stack – Vertical posts. Including freight and Installation services for a cost not to exceed \$ 3,127.41.




