## PREVIOUS ACTION & BACKGROUND

The 9-1-1 Emergency Response Advisory Committee approved reimbursement on May 16, 2019, for the City of Reno PSAP, in the amount of: \$2,582.65, for ten (10) Plantronics Encore HW540 headsets, five (5) Plantronics CA12CD-S PTT, and five (5) SSP 2697-01 headset cables.

# **BACKGROUND**

Seven (7) Plantronics corded PTT headset adapter. This is a PTT corded adapter used for our training staff on the 911 phone system. Each PTT corded adapter: \$123.99.

Total approximate amount: \$950.00



Five (5) Plantronics In-Line Mute Switch designed to mute or not mute the trainee during training sessions on the 911 system. Each Mute Switch: \$24.95
