SUBJECT: FUNDING/REIMBURSEMENT REQUEST - Washoe County Sheriff's Office Communications Center (PSAP) – Requesting funding to purchase/reimburse three (3) Harris Radio Equipment 6-wire Jack Boxes. A review, discussion and possible action to approve, deny or otherwise modify a request to fund/reimburse a total amount not to exceed: \$1,100.00.

SUMMARY

FOR PRIMARY PSAP (Public Safety Answering Point) WASHOE COUNTY SHERIFF'S OFFICE COMMUNICATIONS CENTER:

A review, discussion and possible action to approve, deny or otherwise modify a request to fund/reimburse the equipment purchase of three (3) 6-wire Jack Boxes, which will be used as a spare part to our consoles specifically designed for our Harris Radio System to plug our corded headset into to answer Radio and 911/Phone traffic. Washoe County Communications has exhausted all other like spare parts and we have a need to keep these on hand to keep our consoles functioning. Total purchase not to exceed \$ 1,100.00.

NRS APPLICABLE: *NRS 244A.7645* Provides approval of costs associated with maintenance, upgrade and replacement of equipment necessary for the operation of the enhanced telephone system.

STAKEHOLDER REVIEW(s)

Stakeholder is a primary Public Safety Answering Points (PSAP) – Washoe County Sheriff's Office Communications.

PREVIOUS ACTION&BACKGROUND

911 Emergency Response Advisory Committee has approved the funding of three Harris Radio Consoles for Washoe County Sheriff's Office Communications at the January 2019 board meeting, for the sole purpose of updating two consoles and keeping a spare on site for such incidents where we are left with no radio.

PRODUCT DESCRIPTIONS:

Three (3) Harris Jack Boxes, 6 Wire, designed to be a spare part to our consoles specifically for our Harris Radio System to plug our corded headset to answer Radio and 911/Phone traffic. Each Jack Box: \$ 333.00

Total approximate amount: \$999.00



FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Committee approve the request to fund/reimburse Washoe County Sheriff's Office Communications Center (PSAP) for the requested purchase of: three (3) Harris 6-wire Jack boxes; in an amount not to exceed: \$1,100.00
