This will allow for all Washoe County consoles to be retrofitted the same and fully functional for both Radio and Phone Communications Specialist/Call Takers. SUMMARY

PUBLIC SAFETY EQUIPMENT/LICENSING FOR PRIMARY PSAP (Public Safety Answering Point) **WASHOE COUNTY SHERIFF'S OFFICE COMMUNICATIONS:**
On behalf of the Washoe County Sheriff's Office Communications, I would like to request purchase and funding of (2) Harris Symphony Radio Consoles to meet the continued growing needs of the Washoe County Public Safety Answering Point (PSAP) Communications Center and provide the necessary services for radio communications with the addition of two consoles for two new workstations. A review, discussion and possible action to approve, deny or otherwise modify a request to purchase two (2) Harris Symphony Radio Dispatch Consoles to place on our two new workstations. This will allow for all Washoe County Communications consoles to be retrofitted the same and fully functional for both Radio and Phone Communications Specialist/Call Takers. This amount NOT TO EXCEED: **\$120,724.00.**

NRS APPLICABLE: *NRS 244A.7645*

Provides approval of costs associated with purchasing, leasing or renting the equipment and software necessary to operate the enhanced telephone system, including, without limitation, equipment and software that identify the number or location from which a call is made, upgrade and replacement of equipment necessary for the operation of the enhanced telephone system.

STAKEHOLDER REVIEW(s)

Stakeholders are the area primary Public Safety Answering Points (PSAP) – Washoe County Sheriff's Office Communications, City of Sparks Emergency Communications and City of Reno Public Safety Dispatch, and each PSAP's contracted Agencies.

PREVIOUS ACTION BACKGROUND

On January 17, 2019, the E911 Advisory Board approved the purchase of an additional (3) Harris Symphony Dispatch Radio consoles to retrofit and replace one broken Harris Symphony Console, and purchase an additional two one for the Supervisors console and the other as a hot swap for Washoe County Communications Center to easily swap out Radio Consoles when the console breaks. The consoles were approved spending of \$139,443.65 by the Enhanced 911 Fund for the replacement.

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

RECOMMENDATION


