SUBJECT: REQUEST REIMBURSEMENT FOR FUNDING ADDITIONAL BODY WORN CAMERA(S) AND BODY WORN CAMERA LICENSE(S) [for possible action] - A review, discussion and possible action to approve, deny or otherwise modify a request for funding for additional body worn cameras and licenses for field deployment not to exceed the total amount of \$77,949.70 over 2 fiscal years

SUMMARY

The 79th Nevada Legislature passed Senate Bill 176 (SB 176), which requires uniformed peace officers employed by a law enforcement agency and who routinely interact with the public to wear a body worn camera device effective July 1, 2018. SB 176 expanded the permissible use of the county's 911 telephone line surcharge fund to include the purchase and maintenance of body worn cameras.

Over the past 2 ½ years of using the body worn cameras we have learned several lessons with their deployment and use. While the cameras are very reliable there are times they need to be repaired and spare cameras need to be issued. We underestimated this amount and need additional spare cameras to keep the availability for all officers to have cameras for deployment into the field. We have also grown slightly as a department and need additional cameras for our officers currently in the academy.

The attached contract covers 23 months, which is what is left on our current 5 year contract at which point they will be combined into a new contract at its expiration. Year 1 of the contract is quoted at \$47,877.70 and would be paid this fiscal year. Year 2 is quoted at 30,072.00 and would be paid in the upcoming fiscal year. Total estimated expenditures are 77,949.70.

NRS APPLICABLE:

NRS 244.7643 and NRS 244A.7645 Provides approval of costs associated use of the county's 911 telephone line surcharge fund to purchase and maintain body worn cameras.

STAKEHOLDER REVIEW(s)

Stakeholders are the City of Reno, the Reno Police Department and the community in general.

PREVIOUS ACTION & BACKGROUND

On January 16, 2018, the BCC adopted the policy of the Use of 911 Surcharge Funds for the Body Camera Mandate set forth in Nevada Senate Bill 176.

On January 18, 2018, the Washoe County 911 Emergency Response Advisory Committee adopted the Five Year Master Plan Update, prepared by the Galena Group Incorporated.

On February 20, 2018, the BCC adopted the Washoe County Regional 911 Emergency Response Advisory Committee Five Year Master Plan Update, prepared by the Galena Group Incorporated, as recommended by the 911 Emergency Response Advisory Committee.

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system and the funding of body worn cameras for uniformed peace officers employed by a law enforcement agency who routinely interact with the public. Budget authority exists within the E911 Fund to reimburse the City of Reno for the expense.

The City of Reno will pay the expense of the additional cameras and licensing, and is requesting the Washoe County 911 Emergency Response Advisory Committee recommend to the Board of County Commissioners to approve reimbursement to the agency up to \$77,949.70.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Committee approve the request to recommend to the Board of County Commissioners to approve reimbursement to the City of Reno up to \$77,949.70 for additional body worn cameras and licensing.

POSSIBLE MOTION

Move to approve that the E911 Emergency Response Advisory Committee approve the request for reimbursement to the City of Reno up to \$77,949.70 for additional body worn cameras and licensing.
