NRS APPLICABLE:

NRS 244A.7645 provides approval of costs associated with maintenance, upgrade, and replacement of equipment necessary for the operation of the enhanced telephone system.

PREVIOUS ACTION & BACKGROUND

In May 2020 the E911 Committee approve the replacement of data lines to allow for expansion of Sparks Dispatch. This request is for additional data lines needed for the same project.

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Committee approve the request to fund the costs associated with replacing and adding additional data lines used to connect emergency phone lines and radio equipment to Sparks Emergency Communications Center for a cost not to exceed \$32,000.
