Each year the 911 Emergency Response Advisory Committee has approved the reimbursement of Washoe County Sheriff's Office Communications Platinum ESP Package since the purchase of the call taking software. September 2020 the E-911 Advisory Board approved the ESP funding for Washoe County Sheriff's Office.
