SUBJECT: ANNUAL REOCCURRING FUNDING REQUEST – by WASHOE COUNTY SHERIFF'S OFFICE COMMUNICATIONS CENTER FOR CARBYNE 911 CONTRACT INVOICE. A review, discussion and possible action to approve, deny or otherwise modify this request to fund our current annual contract fee with Carbyne 911 [NG-911 Solution] for an amount NOT TO EXCEED: **\$60,900.00 (annual)**.

SUMMARY

Carbyne 911 is an NG-911 solution that Washoe County Sheriff's Office has been using for the last 24+ months. The company allows for PSAP's to initiate on Emergency and non-Emergency calls for service with citizens that do not know their exact location. In May of 2021, E-911 Board moved and approved the 5-year contract with Carbyne to be paid in annual installments in an amount NOT TO EXCEED: **\$60,900.00**

NRS APPLICABLE: *NRS 244A.7645*

Provides approval of costs associated with purchasing, leasing or renting the equipment and software necessary to operate the enhanced telephone system, including, without limitation, equipment and software that identify the number or location from which a call is made, upgrade and replacement of equipment necessary for the operation of the enhanced telephone system.

STAKEHOLDER REVIEW(s)

Stakeholders are the area primary Public Safety Answering Points (PSAP) – Washoe County Sheriff's Office Communications, City of Sparks Emergency Communications and City of Reno Public Safety Dispatch, and each PSAP's contracted Agencies.

PREVIOUS ACTION BACKGROUND

In May of 2021 the E-911 Committee approved a 5-year contract with Carbyne 911 which is an NG-911 solution (that Washoe County Sheriff's Office has been using) to be paid annually using E-911 funds for an Annual amount NOT TO EXCEED: **\$60,900.00.**

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Board approve the request presented by Washoe County Sheriff's Office Communications Center, to fund the Annual invoice amount NOT TO EXCEED: **\$60,900.00.**
