RENO PUBLIC SAFETY DISPATCH:

NRS APPLICABLE:

NRS 244A.7645 Provides approval of costs associated with maintenance, upgrade and replacement of equipment necessary for the operation of the enhanced telephone system.

STAKEHOLDER REVIEW(S)

Stakeholder is a primary Public Safety Answer Point (PSAP) – City of Reno Public Safety Dispatch.

PREVIOUS ACTION & BACKGROUND

On July 21, 2022 the 9-1-1 Emergency Response Advisory Committee approved reimbursement for Washoe County Sheriff’s Office Communications for the costs associated with IAED EFD software recertification for Dispatchers and Supervisors, for a cost not to exceed \$7,850.00

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Committee approve the request

to reimburse the costs associated with IAED EFD software recertification for Reno Dispatch Dispatchers, Call-takers and Supervisors, for a cost not to exceed \$2,449.50
