NRS APPLICABLE:

NRS 244A.7645 provides approval of costs associated with maintenance, upgrade and replacement of equipment necessary for the operation of the enhanced telephone system.

STAKEHOLDER REVIEW(s)

Stakeholder is the primary Public Safety Answering Points (PSAPs) for Sparks Police Department.

PREVIOUS ACTION & BACKGROUND

Yearly a request is made for funding for individuals from each of the three (3) primary PSAP's to attend Dispatch Training Conferences.

In August 2023, the E911 Emergency Response Advisory Committee approved reimbursement for Sparks PSAP personnel to attend the Hexagon User Conference in November 2023, and in September 2023, the board approved reimbursement for both Reno Public Safety Dispatch and Washoe County Sheriff's Office Communications to attend the Hexagon User Conference in November 2023.

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

Budget authority exists within the E911 Fund to the travel and training to public safety training conferences.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Committee approve the request to reimburse Sparks Police Department PSAP for the costs associated with three dispatch personnel attending the Hexagon Public Safety 2024 North American Summit Conference in September 2024, for an amount not to exceed \$12,000.
