### PREVIOUS ACTION&BACKGROUND

On January 16<sup>th</sup>, 2025, the 911 Emergency Response Advisory Committee approved the funding to purchase United States Spanish (USS) language software licensing for Priority Dispatch ProQA EMD & EFD for Washoe County Sheriff's Office Communications PSAP.

On November 21, 2024, the 911 Emergency Response Advisory Committee approved the reimbursement for Priority Dispatch ProQA EMD (licensing and maintenance) for the City of Reno Public Safety Dispatch PSAP.

On March 21, 2024, the 911 Emergency Response Advisory Committee approved the reimbursement for Priority Dispatch ProQA EFD (licensing and maintenance) for the Sparks Police Department PSAP.

On January 16, 2020, the 911 Emergency Response Advisory Committee approved the funding request to purchase two (4) Harris Symphony Consoles for Sparks Police Department Communication's Center.

### FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

### **RECOMMENDATION**


