PREVIOUS ACTION BACKGROUND

In the E911 Emergency Response Advisory board meeting November 2024, the Board approved funding to reimburse the County for same/like classes. Additionally, the E-911 Board has traditionally funded the region's training which enhances our ability to instruct citizens over the phone during Police, Fire, and/or Medical events.

FISCAL IMPACT

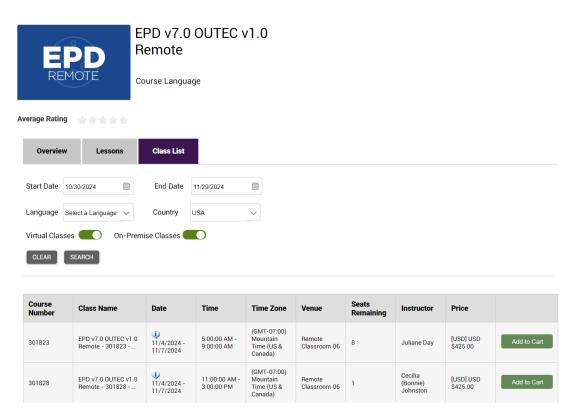
The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system. Budget authority exists within the E911 Fund to the travel and training to the public safety training conferences for registrations, seminars and meetings.


RECOMMENDATION



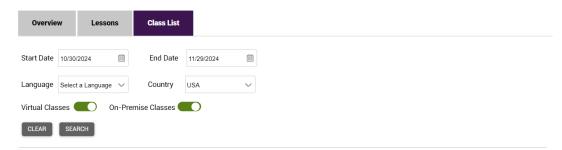



Completion of this module is required to achieve certification through the International Academies of Emergency Dispatch.

Be aware that the exam is based on the MPDS cardset not the automated software (ProQA®).

Prior to attending the EMD classstudents must complete all current OUTEC lessons and successfully complete the associated OUTEC exam or have successfully completed an ETC Course within the past two years.

Students who have not met the OUTEC requirement will<u>not be admitted</u>to the training and will need to reschedule for a later class.

The EMD Module is a twenty-four-hour Instructor led training in either an On-site or Remote (Online) environment. On-site training will consist of three nine-hoursessions of EMD specific content (includes a lunch break). Remote training will consist of six four-hour sessions of EMD specific content. Full attendance at all sessions is required to be eligible for the final certification exam. To be EMD-certified the applicant must also be CPR-certified through the National Safety Council American Heart Association American Red Cross European Re
