STAKEHOLDER REVIEW(s)

Stakeholders are the area primary Public Safety Answering Points (PSAP) – Washoe County Sheriff's Office Communications, City of Sparks Emergency Communications and City of Reno Public Safety Dispatch, and each PSAP's contracted Agencies.

PREVIOUS ACTION BACKGROUND

On May 15th, 2025, the E-911 Committee approved the purchase of Watson Dispatch console workstations for the co-located Communications Centers for City of Reno and Washoe County.

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Board approve the request co-presented by Washoe County Sheriff's Office Communications and the City of Reno Public Safety Dispatch co-located Centers at 5195 Spectrum Blvd. to optimize space by removing the elevated flooring in an amount NOT TO EXCEED: **\$15,893.00**
