NRS 244A.7645 provides approval of costs associated with maintenance, upgrade and replacement of equipment necessary for the operation of the enhanced telephone system.

STAKEHOLDER REVIEW(s)

Stakeholder is the primary Public Safety Answering Points (PSAPs) for Sparks Police Department.

PREVIOUS ACTION & BACKGROUND

On July 21, 2022, the E911 Emergency Response Advisory Committee approved reimbursement for Washoe County Sheriff's Office Communications for the costs associated with IAED EFD/EMD/EPD software training recertification.

In May 2020, and on November 17, 2022, funding was approved for Sparks IAED EFD. Today's request is for reimbursement for three (3) Priority Dispatch IAED ETC (Emergency Telecommunicator) training certifications for three (3) new dispatchers for Sparks PSAP. This course provides critical training on call management techniques and the importance of quality improvement with the IAED protocols.

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Committee approve the request to reimburse Sparks Police Department PSAP for the costs associated with Priority Dispatch IAED ETC certifications for Sparks Police Department PSAP, in the amount of \$1,050.00.
