SUBJECT: RECOMMENDATION TO APPROVE REIMBURSEMENT FOR: **Laptops for Training**

SUMMARY:

Laptops: The Communications Center purchased laptop computers to support Field Training Officers (FTOs) responsible for training new Communications Specialists. The laptops allow FTOs to complete Daily Observation Reports (DORs) and other required training documentation while actively working on the operations floor. This equipment improves efficiency in documenting trainee performance and supports the department's structured training program.

NRS APPLICABLE: NRS 244A.7645

Provides approval of costs associated with purchasing, leasing or renting the equipment and software necessary to operate the Communication Center.

STAKEHOLDER REVIEW (s)

Stakeholders are the area primary Public Safety Answering Points (PSAP) – Washoe County Sheriff's Office Communications, City of Sparks Emergency Communications and City of Reno Public Safety Dispatch, and each PSAP's contracted Agencies.

PREVIOUS ACTION & BACKGROUND

Field Training Officers do not have assigned desks or dedicated workstations where they can complete training documentation. As a result, completing Daily Observation Reports (DORs) and other evaluation materials has been challenging while simultaneously monitoring and training new staff. The purchase of portable laptops allows FTOs to complete required documentation in real time while working alongside trainees, ensuring accurate evaluations and maintaining consistency within the Communications Center training program.

FISCAL IMPACT

The Enhanced 911 Fund is a special revenue fund which receives revenue pursuant to NRS 244A.7643 in the form of telephone surcharges collected to support the emergency reporting system.

RECOMMENDATION

It is recommended that the E911 Emergency Response Advisory Board approve the request presented by Washoe County Sheriff's Office Communications Center, to fund the invoice amount NOT TO EXCEED: **\$8398.38**
