Lori Piccinini, Washoe County, gave an update on the status of the Accela Regional Business License and Permit Platform go live date of October 31, 2016.

Steve Driscoll, Sparks City Manager, requested additional information about the nature of issues found during the citizen review. Ms. Piccinini responded that most of the issues were regarding the font size and that some of the screens within the process were redundant.

Mr. Driscoll questioned whether one agency having limited access to one of the key components of the system will cause any issues for any of the other agencies systems. Ms. Piccinini responded that this will create no issues for any of the other agencies as the key component referred to is a stand-alone function.

Mr. Driscoll asked if information had been received from the State of Nevada regarding the potential changes to SilverFlume and how this will affect the work already done towards an interface. Ms. Piccinini stated that nothing additional had been received from the State and that there is the potential that some pieces of the interface which have already been completed will need to rewritten. Bob Webb, Washoe County, also added that Accela Regional Coordinating (ARC) Team has been focusing on the go live date. The ARC Team plans to reconnect with the State after the go live date to attempt to resolve these issues.

Mr. Driscoll asked if the linking of ACA customers with their renewal or previous accounts was a functionality which was originally part of the Statement of Work. Ms. Piccinini stated that this was originally believed to be an existing feature through Accela, but as the project progressed this was proven to not be the case.

John Slaughter, Washoe County Manager asked if Accela and True Point are ready for the October 31st go live date. Peri Halliwell, Accela, and Keith Hobday, TruePoint, each stated that their organizations are both ready for the go live date.
