## Addendum G – Additional Participating Agency Truckee Meadows Fire Protection District

Addendum G to the AGREEMENT joins Truckee Meadows Fire Protection District (TMFPD), a political subdivision of the State of Nevada, to the PROGRAM as one of the PARTICIPATING ENTITIES.

TMFPD is a public agency that wishes to join as a PARTICIPATING ENTITY in the PROGRAM.

The AGREEMENT's Article 13 provides that public agencies may join the PROGRAM on OVERSIGHT GROUP approval.

At the December 10, 2020, OVERSIGHT GROUP quarterly meeting, the OVERSIGHT GROUP approved TMFPD joining the PROGRAM.

Under Article 13, when TMFPD joins the PROGRAM, TMFPD will have all of the rights, privileges, obligations, and liabilities under the AGREEMENT as the PARTICIPATING ENTITIES.

On entering the PROGRAM, TMFPD will fulfill the obligations imposed on, and enjoy the rights of the PARTICIPATING ENTITIES under the vendor contract between the FISCAL MANAGER and Accela.

On entering the PROGRAM, TMFPD will not purchase additional subscriptions in fiscal year 2020–2021. TMFPD currently uses 4 Accela Automation back-office licenses, 1 for the Admin use and 4 Accela Mobile Office

TMFPD's costs and fees for joining and participating in the PROGRAM will be as set forth the attached Memorandum Re: TMFPD Costs to Enter the Accela One Regional Platform from Washoe County Technology Services ("Memorandum"), as set forth in Exhibit A, and the vendor's contract's EXHIBIT C – PRICING EXHIBIT.

TMFPD will be entering the PROGRAM in fiscal year 2020–2021. TMFPD will not incur any additional costs during the 2020–2021 fiscal year. TMPFD currently uses subscriptions through Washoe County's Building Module, including 4 Accela Automation licenses, 1 Administrative User, and 4 Accela Mobile Office licenses. If TMFPD wishes to add licenses beyond its current utilization, TMPFD will complete an order form and pay for any remaining portion of that year.

Washoe County, as the PROGRAM's FISCAL MANAGER, will not charge TMFPD operating expenses for the 2020–2021 fiscal year. Operating expenses may be reviewed and charged in the future.
